Mr P Carr again requested that a 'road hazard' (a cracked BT inspection cover on Church Fields Corner marked by a cone since October 2015), it be corrected in the interest of Road Safety for all road users. Mrs N Uden reported: Early Starts at DAT on 24/25th May at 8 oclock - waiting for an update from engineers re; broadband? - the reported tree work has had to be stopped due to nesting birds – the reported PO closure has upset some residents in that they were not all aware of that information before it was announced. Mrs N Uden publicly apologised for any upset caused – a question from Mrs M Hucking re: General explosions appear to be getting louder causing alleged damage to housing - in response Mrs N Uden reported: An exercise by an independent body is being carried out to test and to measure all parameters of the present effects of the explosions. The results will be analysed and published by the MOD - expected in the late Summer 2016.
